Request under Freedom of Information Act 2000

Thank you for your request for information which we received on Monday 10th July 2023. I am pleased to confirm the following.

1a) Divided by month, how long the waiting list is for getting a breast reconstruction after a mastectomy from January 2016 to July 2023 (or the most up-to-date data)?

We aim for immediate reconstruction within 62-day target, we have slipped over the last 3-months with a few patients, to up to an additional 2 weeks. With the delayed reconstruction we are currently running at 8 -9months from listing as there is the pressure of cancer work.

1b) Please divide this information according to different types of breast reconstruction i.e., implant, LD flap, DIEP flap.

We are only performing implant-based reconstruction.

2) Divided by month, how many people are on the waiting list for breast reconstruction after a mastectomy from January 2016 to July 2023 (or the most up-to-date data)?

We have 3 patients waiting for delayed reconstruction (waiting 3, 4 and 6 months), and 2 waiting for immediate mastectomy and reconstruction who are timetabled for surgery within 62days of surgery (59 and 62days respectfully)

3a) What date did the trust stop performing reconstructions at the same time as mastectomies during the pandemic?

1st April 2020 we stopped performing and reconstruction.

3b) What date did the trust start offering reconstructions at the same time as mastectomies again?

12th May 2020 we performed our first mastectomy and reconstruction.
