Guardians were only put in place from 2016 because of the Mid-Staff enquiry outcomes. At MKUH two Guardians were appointed in 2016 who were 'part-time', fitting the role into their usual jobs.

In 2019 there was one Guardian appointed who was required to fit the role into their full-time working hours.

During the 2022 the Lead Guardian reduced their main role to 4 days a week and had one day per week as a paid Guardian.

The total at the end of 2022 equated to 3 full days of Guardian time.





It has been the same 5 Guardians since 2019 (the Current Lead) and subsequent four added in 2021, plus the original two making 7 Guardians in total.
