## Request under Freedom of Information Act 2000

Thank you for your request for information which we received on Monday 5<sup>th</sup> February 2024. I am pleased to confirm the following.

I am writing to request, under the Freedom of Information Act, a copy of any communication received by your Trust from NHS England in the last 6 months, which instructs or suggests that the trust focuses its energy on patients in emergency departments who do not need to be admitted to a ward, in order to improve the Trust's performance against the 4-hour A&E target.

Since January 2024 the Trust in response to national NHS England steer have been implementing its Urgent Emergency Care Recovery Plan utilising the national improvement tool set out by NHS England. The tool focuses on a number of areas from Streaming & Redirection & Initial Assessment, Senior Decision Maker & RAT (stationary and roving), Maximising the use of UTCs, Improving Ambulance Handovers & Direct Access, and Reducing Time in Department - 12 hours & IPS & Escalation. All areas of improvement have defined metrics for the Trust to meet.

Unfortunately we are unable to share the details of the letter due to the publication being owned by NHS England under the Government Security Classification Scheme as OFFICIAL - however, the individual requesting the FOI can contact england.universalsupportoffer@nhs.net to enquire further.
