Thank you for your request for information which we received on Thursday 29th February 2024. I am pleased to confirm the following.

We provide a summary of the number of Employee Relations (ER) cases to the Trust Board as part of the regular workforce report. We produce an annual report of ER activity to the Board Workforce Committee. Individual reports are sent to Private Board when a doctor is excluded.

4. Have all Case Investigators and Case Managers conducting disciplinary processes within your Trust undertaken mandatory training on the disciplinary process?

This training is not part of the Trustwide statutory and mandatory training which all staff must undertake. However, there is training available for investigations and hearings and it is best practice for newly appointed managers to attend this prior to carrying out an investigation.
