Thank you for your request for information which we received on Friday 9th February 2024. I am pleased to confirm the following.

What team name(s) your organisation uses when calling 2222 for a Medical Emergency.

There are designated emergency bleep calls dictated by the caller request via Switchboard ie adult cardiac arrest/ Trauma call(adult paeds)/ obstetric haemorrhage/ obstetric emergency/ cat 1 section / stroke / difficult airways NNU & adult/ Neonatal emergency / major haemorrhage / paeds arrest / fast bleep for all specialty on take services and Rapid response team (other 2222 calls are child/baby abduction / majax / code victor(violence agression)/ fire)

Do you have more than one tier system?

Bleep System for emergency bleeps with contingency in place. Only have 2222 as Emergency call system. Ward calls to on take ward-based Drs and Rapid response bleep could be considered as first point of escalation using SBAR process.

If more than one team, please can you provide a breakdown of what types of emergencies you would expect each team to be activate for.

There are designated emergency bleep calls dictated by the caller request via Switchboardie adult cardiac arrest/ Trauma call(adult paeds)/ obstetric haemorrhage/ obstetric emergency/ cat 1 section / stroke / difficult airways NNU & adult/ Neonatal emergency / major haemorrhage / paeds arrest / fast bleep for all specialty on take services and Rapid response team (other 2222 calls are child/baby abduction / majax / code victor(violence aggression)/ fire)

Each team varies depending on the type of emergency i.e. Doctors/ nurses/ Anaesthetists/ porters/ theatre staff / midwifes/ security.
