## Request under Freedom of Information Act 2000

Thank you for your request for information which we received on Wednesday 20<sup>th</sup> March 2024. I am pleased to confirm the following.

## For the calendar years 2019, 2020, 2021, 2022, and 2023, please provide:

The number of midwifery "red flag" incidents (examples provided here: <u>https://www.nice.org.uk/guidance/ng4/chapter/recommendations#box-3-midwifery-red-flag-events</u>) identified in your maternity departments, broken down by year

We are only able to provide calendar year data for 2023, this is due to Birthrate Plus acuity tool being implemented 2022, prior to this red flag data documented on paper.

In 2023 there were 238 red flags raised via the Birthrate Plus acuity tool.

If your organisation has other "red flag" incidents agreed locally, please specify what they are and how many occurred per year.

We do not have any agreed local red flags.

Of these, please specify how many of these incidents (as a proportion - i.e. 65%, and the raw number) related to staffing levels.
